SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Small Fire : Dry chemical, foam, carbon dioxide, water-spray or alcohol-resistant foam. Large Fire: Dry chemical, CO2, alcohol resistant foam or water spray Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces.

Unsuitable Extinguishing Media

Fire-fighting Procedures

Caution should be exercised when using water or foam as frothing may occur, especially if sprayed into containers of hot, burning liquid. SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Isolate hazard area and keep unauthorized personnel away. Do not touch or walk through spilled material. Ventilate closed spaces before entering.

Recommended Equipment

Personal Precautions

Avoid breathing vapor or mist. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing.

Environmental Precautions

Methods and Materials for Containment and Cleaning up

SECTION 7) HANDLING AND STORAGE

General

Store in cool, dry, well-ventilated areas away from heat, direct sunlight and strong oxidizers. Keep container(s) tightly closed and properly labeled. Containers that have been opened must be carefully resealed to prevent leakage.
